

# Multinet Gas – Privacy Policy

Multinet Gas complies with the Australian Privacy Principles (Principles) under the Privacy Act 1988 (Privacy Act) and with any other applicable laws that protect your privacy. The Principles are designed to protect the confidentiality of information and the privacy of individuals by regulating the way Personal Information is managed. Personal Information is generally, information or an opinion relating to an individual, which can be used to identify that individual.

This Privacy Policy sets out our Personal Information management practices.

## 1. Definitions

In this Privacy Policy:

**Australian Privacy Principles** refers to the set of harmonised privacy principles that regulate the handling of Personal Information by both Australian government agencies and businesses.

**Personal Information** means information or an opinion (including information or an opinion forming part of a database), whether true or not, and whether recorded in a material form or not, about an individual whose identity is apparent or can reasonably be ascertained from the information or opinion.

**Primary Purpose** means the purpose for which Personal Information is collected. For example, for the purposes of connection, disconnection or maintenance of the supply of gas, the provision of metering services or any other services which are offered or provided by Multinet Gas.

**Privacy Act** means the *Privacy Act 1998* (Cth).

**Secondary Purpose** means a purpose other than the Primary Purpose of collection. These purposes may include: insurance, marketing, investigations, network issues, business planning and notifying customers of United Energy's services.

**Sensitive Information** means:

- (a) Personal Information which comprises information or an opinion about an individual's:
  - i. racial or ethnic origin;
  - ii. political opinions;
  - iii. membership of a political association;
  - iv. religious beliefs or affiliations;
  - v. philosophical beliefs;
  - vi. membership of a professional or trade association;
  - vii. membership of a trade union;
  - viii. sexual orientation or practices;
  - ix. criminal record;
- (b) health information about an individual; or
- (c) genetic information about an individual that is not otherwise health information or
- (d) biometric information that is to be used for the purpose of automated biometric verification or biometric identification; or
- (e) biometric templates.

**Multinet Gas** means Multinet Gas Distribution Partnership (acting on behalf of Multinet Gas (DB No 1) Pty Ltd and Multinet Gas (DB No 2) Pty Ltd), its related bodies corporate within the meaning of the *Corporations Act 2001* (Cth) and UE & Multinet Pty Ltd.

## 2. Purpose, kinds and collection of Personal Information

Multinet Gas will only collect Personal Information if the information is necessary for one or more of its functions and activities, that is, a Primary Purpose and/or associated Secondary Purposes. For example, we may collect your Personal Information to connect or maintain supply of gas or to resolve any queries you may have.

Our Personal Information holdings includes complaints and contact details. Should you provide your contact information including email address or mobile telephone number, unless you tell us otherwise, you consent to us using this information to contact you for any of our Primary Purposes.

Where it is reasonable and practicable to do so, Multinet Gas will collect Personal Information directly from you. However, there are situations in which we may collect Personal Information about you from a third party, for example, your retailer. We handle all personal (including sensitive information) collected from third parties about you in accordance with this Privacy Policy. Where Multinet Gas collects Personal Information directly from you, Multinet Gas will endeavour to ensure that you are aware of:

- (a) our corporate and contact details;
- (b) your ability to gain access to the information;
- (c) the purposes for which the information is collected;
- (d) the organisations (or types of organisations) to which Multinet Gas usually discloses information of that kind;
- (e) any law that requires the particular information to be collected; and
- (f) the main consequences (if any) for you if all or part of the information is not provided.

In certain circumstances, Multinet Gas may collect Sensitive Information where it is necessary to achieve a Primary Purpose, or a Secondary Purpose which is directly related to the Primary Purpose. For example, we may collect certain health information to assist in meeting your special requirements in supplying gas to you.

## 3. Use and disclosure of Personal Information

Multinet Gas will only use and disclose your Personal Information for either:

- (a) the Primary Purpose; or
- (b) a Secondary Purpose where either you have expressly consented to such use or disclosure, or it is related to the Primary Purpose of collection and you would reasonably expect such use or disclosure.

Multinet Gas may use or disclose Personal Information to unrelated third parties for such purposes, including to the following:

- (a) our service providers who assist us in providing our services;
- (b) gas retailers and other gas market participants (such as the Australian Energy Market Operator (AEMO)) to ensure they have sufficient information for billing customers

We may use or disclose your Personal Information where required or authorised by law, which may include emergency situations and assisting law enforcement agencies.

We will not use your Personal Information for marketing purposes where you have requested that you do not wish it to be used in this way.

We may use your Personal Information to promote and market products and services to you, including through telephone and electronic methods such as email, SMS and websites. This is to keep you informed of products, services and special offers and may continue after you cease to acquire services from us.

Unless you have opted out, we may provide marketing communications to you. If you do not wish us to contact you to promote products, services and special offers (whether it be through electronic methods or

otherwise), or if you have subscribed to any of our newsletters or subscriptions and no longer wish to receive such communications, please contact us using the “Contact Details” set out in Section 10 below.

In circumstances where Multinet Gas receives unsolicited Personal Information, and the information is not contained in a Commonwealth record, Multinet Gas will as soon as practicable destroy or de-identify it the information.

## 4. Storage, information quality and security

Multinet Gas may store Personal Information with a third-party data storage provider. Multinet Gas will take reasonable steps to protect the Personal Information it holds from misuse and loss and from unauthorised access, modification or disclosure. To the extent required by the Privacy Act reasonable steps will be taken to make sure that Personal Information we collect, use and disclose is accurate, complete and up to date. We will also take reasonable steps to destroy or permanently de-identify Personal Information if it is no longer needed for a Primary Purpose or Secondary Purpose.

## 5. Destruction or de-identification

We will destroy or de-identify information about you in accordance with the Privacy Act. This will generally mean that information is destroyed when no longer needed.

## 6. Anonymity

Multinet Gas will generally provide individuals with the option of not identifying themselves when entering transactions when it is lawful and practicable to do so. However, on many occasions we will not be able to do this. For example, we will need your name and address in order to provide you with gas connection.

## 7. Accessing and updating your Personal Information

Multinet Gas will take reasonable steps to ensure that the Personal Information (both in electronic and hard copy form) it collects, uses or discloses is accurate, complete and up-to-date. Please inform us of any changes to your Personal Information.

If you need to access or update any Personal Information we hold about you, please contact us using the “Contact Details” set out in Section 10 below. We request that you provide us with as much detail as you can about the particular information you seek, in order to help us retrieve it. An administration fee may be charged to cover our costs of providing that information to you.

In certain circumstances, we may not be required by law to provide you with access to your Personal Information. For example, where providing access would be unlawful, pose a serious and imminent threat to the life or health of any individual, would have an unreasonable impact upon the privacy of other individuals or where the request for access is frivolous or vexatious. If we do not provide you access to your Personal Information, we will give you our reasons for that decision.

## 8. International transfer of Personal Information

Multinet Gas will only transfer Personal Information about an individual to a third party in a foreign country in accordance with the Privacy Act. Some of the countries third parties may be located include India, the Philippines, Singapore, Hong Kong, China, the United Kingdom, Bermuda and the USA. You acknowledge that:

- (a) they may have obligations that differ from Australian privacy laws;
- (b) we will not be accountable for the third party under the Privacy Act;
- (c) you may not be able to seek redress under the Privacy Act; and
- (d) the third party may be subject to foreign laws in relation to Personal Information.

Circumstances where such disclosure is permitted under the Privacy Act include if we believe that the recipient is subject to a law, binding scheme or contract which effectively requires Personal Information to be handled in a similar manner as the Australian Privacy Principles, or if you consent to the transfer.
